- (b) adding a bridleway from Ordnance Survey Grid Reference (OSGR) 65138,29409 (point E) to OSGR 65138,29385 (point F) as shown on the order map.

Public footpaths, bridleways, restricted byways and byways open to all traffic are recorded on definitive maps and statements. These maps and statements provide conclusive legal evidence of the existence of public rights. Suffolk County Council is responsible for the definitive map and statement and has a duty to amend them when evidence suggests that they are inaccurate or incomplete. Such amendments are made by means of modification orders under section 53 of the Wildlife and Countryside Act 1981. These orders do not come into effect until confirmed, and if there are any objections the County Council must refer the order and objections to the Department of Environment, Food and Rural Affairs in Bristol.

The County Council has been directed by an Inspector appointed by the Secretary of State for Environment, Food and Rural Affairs to make a modification order under Section 53 to upgrade three public footpaths in Oulton to bridleway status, and part of one in Lowestoft, and to add a bridleway, as detailed in these orders. The orders simply recognise the public rights that are believed to exist. The orders do not create any new public rights.

If there are no objections to an order, or if all objections are withdrawn, the County Council will confirm the order, and the definitive map and statement will then be modified. If there are any objections which are not withdrawn, the County Council must refer the order and objections to the Department of Environment, Food and Rural Affairs, who will appoint an independent Inspector to consider the order and hear the objections, normally by holding a public inquiry. The Inspector may confirm the order, with or without modifications, or may decide that the order should not be confirmed.

This Order is made by Suffolk County Council (the "Authority") under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act"), in accordance with a direction made to the County Council by an Inspector appointed by the Secretary of State under paragraph 4(2) of Schedule 14 to the Act, to modify the Definitive Map and Statement for the parish of Oulton in the district of East Suffolk in consequence of the occurrence of events specified in sections 53(3)(b) and 53(c)(i) namely, the expiration, in relation to any way in the area to which the map relates, of any period such that the enjoyment by the public of the way during that period raises a presumption that the way has been dedicated as a public path; and the discovery of evidence which shows that a bridleway which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates.

The Authority has consulted with every local authority whose area includes the land to which the Order relates. The Suffolk County Council hereby orders that:

- 1. For the purpose of this Order the relevant date is 1 June 2023.
- 2. The Definitive Map and Statement for the parish of Oulton in the district of East Suffolk shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the Order.
- 3. This Order shall take effect on the date it is confirmed and may be cited as the Suffolk County Council (Parish of Oulton Bridleway 14) Modification Order 2023.

Modification of Definitive Map

Description of bridleway to be added:

There shall be added to the Definitive Map for the parish of Oulton in the district of East Suffolk a bridleway from Ordnance Survey grid reference (OSGR) 65138,29409 (point E) to OSGR 65138,29385 (point F) as shown on the attached map.

PART 2

Modification of Definitive Statement

Particulars of bridleway to be added:

There shall be added to the Definitive Statement for the parish of Oulton in the district of East Suffolk the following particulars:

Oulton Bridleway 14

Commencing at a junction with Oulton footpath 8 at Ordnance Survey Grid Reference (OSGR) 65138,29409 (point E) and proceeding in a south south-easterly direction across a field for 81 metres to OSGR 65141,29402 changing to a south south-westerly and continuing for 170 metres and terminating at a junction with Woods Lane at OSGR 65138,29385 (point F).

Width: 3 metres

NB. In the absence of a specific width from the user evidence, 3 metres is considered to be a reasonable width allowing two equestian users to pass.
